WHEREAS

That in order to facilitate professional career choices through access to direct knowledge of the work place, and achieve exchange between both study and work processes through vocational education, the subjects referred to in art. 18, paragraph 1, letter "a", of the legal normative dated, 24 June, 1997 no. 196, can encourage apprenticeship and counselling services for access to the work place. This regards all those candidates who have completed a compulsory education in accordance with normative dated, 31 December, 1962 n. 1859

IT IS AGREED UPON AS FOLLOWS

Article 1

1. Pursuant to art. 18 of normative 24 June, 1997 n. 196, the Host Institution agrees to accept to its facilities internship students for vocational preparation and orientation relating to work place proposals originating from the University of Enna "Kore", also pursuant to art. 5 of normative 196/1997.

2. At the beginning of each academic year both subjects, promoter and host, will agree formally through written correspondence on establishing the total annual number of candidates selected to participate in the preparation for apprenticeship and orientation, taking into consideration the degree course background of the trainees.

Article 2

1. The vocational training and orientation process-pursuant to art. 18, paragraph 1, letter "d" of Act No. 196/1997-does not constitute of in itself a contractual employment relationship.

2. During the training period, the candidates' vocational preparation and guidance is followed and monitored by a tutor appointed by the Promoter as the teaching and

internship director, and also by a tutor in the Host Institution.

3. For each trainee received by the Host Institution in accordance with this Convention, internship training and guidance programs will be created including:

4.a) The complete nominatives of the trainee, tutor and company representative; b) The objectives and modalities of the training program, and the duration of time necessary at the Host Institution to reach the pre-established goals; c) The physical facilities that will be involved (sites of business, departments, offices) in the apprenticeships d. INAIL Assurance.

Article 3

1. During the apprenticeship training process and orientation program, the trainee is required: to fully carry out the activities under project parameters and guidance; comply with the governing norms for proper hygiene, health and safety in the workplace; maintain necessary confidentiality with regard to data (information or knowledge about production processes and products) acquired during the internship.

Article 4

1. The Promoter ensures trainees against work incidents through INAIL, as well as for the participants civil liabilities, similarly through local insurance companies. In case of accident during the course of the internship, the Host Institution agrees to report such an incidence within the time required by law both to the appropriate insurance institutions involved (referring to the insurance policy number undersigned by the Promoter), and the Promoter.

2. The Promoter agrees to send to the Region or the delegated Province as well as to the provincial Ministry of Labour and Social Security, which is responsible for the territory in relation to inspection procedures, and also appropriate trade union representatives, a copy of the Convention and of each project's training and orientation program.

Article 5

1. This present Convention has the duration of one year, initiating from its signature. It shall be automatically renewed for the following year, unless terminated by either party through either registered letter with acknowledgment of receipt, or by certified mail to be sent at least sixty days before the expected date of deadline.
